1 INTRODUCTION

1.1 BACKGROUND

1.1.1. The following report has been prepared on behalf of Omega Warrington Ltd and provides the results of reptile surveys undertaken at Omega Zone 8, St Helens ('The Site').

1.2 LOCATION

1.2.1 The Site forms part of the Omega business estate located west of Warrington, falling just within St Helens Borough. It is immediately south of the M62, west of Junction 8, and immediately west of the Warrington District County boundary and Lingley Mere.

1.3 PROPOSALS

1.3.1 This is a hybrid application for full and outline planning permission:

Hybrid Planning Application

- i. Full Planning Permission for the erection of a B8 warehouse, with ancillary offices, associated parking, infrastructure, and landscaping; and
- ii. Outline Planning Permission for Manufacturing (B2) and Logistics (B8) development with ancillary offices and associated car parking, landscaping and infrastructure (detailed matters of appearance; layout and scale are reserved for subsequent approval)

1.4 SITE DESCRIPTION

1.4.1 The Site (~75.5 ha) is dominated by arable land with woodland belts, a network of ponds and ditches improved grassland and scrub habitat present. A brook runs through the centre of the Site from the northwest and adjoins to the southern boundary. Off-site woodland is present to the south and west of the Site and a woodland belt forms the eastern boundary.

1.5 REPTILES LEGISLATION

1.5.1 Both slow worms and grass snake are provided partial protection under Section 9(5) of the Wildlife and Countryside Act 1981, making it unlawful to deliberately or recklessly kill or injure an animal.









2 METHODS

2.1 METHODS OF SURVEY

- 2.1.1 Reptile Presence/absence surveys were carried out throughout the site during May through June 2019. Surveys comprised of 5 visits to c.90 refugia set out across suitable habitat throughout The Site following Froglife 1999 methods¹.
- 2.1.2 The standard method of deploying artificial refuges, which reptiles use to bask on or shelter under was employed. Circa 90 artificial refuges were made of roofing felt cut into approximately 0.5m x 0.5m sheets and deployed at The Site in areas of favourable reptile habitat, as seen in Figure 2.



3 RESULTS

3.1 REPTILE SURVEYS

3.1.1 No evidence of reptile presence were recorded during the first 5 field surveys at the site, as such the surveys were discontinued. Results are found in Table 1.
